\_\_\_\_\_ Dog Tired LLC agrees to exercise due diligence and reasonable care and to keep the premises sanitary and properly enclosed. All pets are handled or cared for by Dog Tired LLC staff without liability on Dog Tired LLC's part for loss or damage from disease, theft, fire, death, escape, injury or harm to persons, other pet(s) or property by said pet, or from other unavoidable causes, due diligence and care having been exercised.

\_\_\_\_\_ Owner is aware of the risks involved with their pet interacting with other pets in a group setting. These include, but are not limited to, scrapes, cuts, bites, and viral and bacterial infections.

\_\_\_\_\_ Should any pet become ill or seem to be in need of medical consideration, Dog Tired reserves the right to administer aid and/or to use any available veterinarian. Any expenses so incurred shall be paid by the Owner of said pet in addition to the fees incurred for services provided at or by Dog Tired LLC.

\_\_\_\_\_ Owner agrees to pay the rate for services in effect on the date their pet is checked into Dog Tired LLC. Prices are subject to change at any time, without notice. Dog Tired LLC reserves the right to hold pet until all charges are paid in full. Cancellation fees apply if 24-hour advance notice is not given.

\_\_\_\_\_ **Pet must be current on all vaccinations: Rabies, DHLPP, Bordatella, and mandatory monthly scheduled prevention program for flea/ticks/lice (applied by a licensed vet or by a Dog Tired staff member). If the animal leaves the State of Alaska it must be on heartworm preventative. Dog Tired LLC reserves the right to refuse service to any dog not current on these protocols.**

\_\_\_\_\_ Owner is aware that reservations are required 24 hours in advance; likewise, notice of reservation cancellation must be received no later than 24 hours prior to the scheduled appointment. If notice is not received, owner agrees that their daycare package will be charged for the visit.

\_\_\_\_\_ Owner agrees that pet will be picked up by Owner or a pre-approved Owner's agent by closing time on scheduled pick-up date. **Owners will be charged a \$2.00 per minute late fee for pick up after 7 PM.** Any pet not picked up within 24 hours will be considered abandoned and will be turned over to the Anchorage Animal Care and Control Center along with Owner's contact information. Any expenses incurred for the transport, overnight care, and /or placement or adoption of said pet shall be paid by the Owner in addition to other fees incurred for services provided by at or through Dog Tired LLC. Owner hereby grants a lien on said pet for any and all unpaid charges resulting from services provided by at or through Dog Tired LLC.

\_\_\_\_\_ Owner agrees that their pet may be videotaped photographed and/or recorded without notice. Dog Tired LLC shall be the exclusive owner to the results and all proceeds of such tapings, photography and recordings with the rights throughout the world, an unlimited number of times in perpetuity, to copyright, to use and to license to others in any manner. Owner further agrees that their pet may be used in any and all media and in the promotion, advertising, sale, publicizing, and exploitation of Dog Tired LLC without notice to the owner.
